 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application;
 - j) The institution shall be free to post additional relevant information, If it so desires.





5. The Course Fee is Rs.60,000/- per annum including University Examination Fee Rs.1000/-. Total course fee for 2 years is Rs.1, 20,000/- per student.
6. The sum of Rs. 100,000/- is to be paid by the college to the University as Affiliation Fee (Annually).
7. The same Inspecting Team of the University shall visit the **Bishnupur Public Primary Teachers Training Institute, Vill.- Ramananda Nagar (Chougan),P.O.- Bishnupur, Dist.- Bankura, West Bengal – 722122** within 3 months from the date of commencement of classes.
8. The College authority shall abide by the Acts, Statutes etc of the University of Burdwan as are in force or as may be amended from time to time.
9. Admission of students will be as per norms stipulated by the University.
10. Procurement of books and laboratory equipments for the library and the laboratories are to be arranged before the commencement of the classes.
11. The College authority should invariably ensure the pay structure of teaching and non teaching staff of the college as per University / State Government / UGC norms.
